This Resolution approved the Statute of the National Center for Human Rights of the Republic of Uzbekistan and the structure of the National Center. The National Center for Human Rights of the Republic of Uzbekistan is a state interdepartmental body for analysis, clarification and coordination. In other words, this body coordinates the activities of public administration bodies in the field of human rights, develops a national plan of work in the field of human rights, prepares national reports on human rights in Uzbekistan, and creates an information base for civil servants in the field of human rights protection. teaches them, gives advice, conducts propaganda work.



Therefore, it is necessary to be noted that the main goal of the Center is to develop and implement the National Action Plan in the field of human rights, a multifaceted system of protection of rights and freedoms through the comprehensive solution of these priorities. Experts stressed that the guarantee of human rights and freedoms is an important indicator of the rule of law, an integral part of an open and just society, the compliance of the national political and legal system with international legal norms and standards. From the first days of independence, the realization of the highest democratic goals, deep-rooted values, embodying human rights, freedoms and legitimate interests in Uzbekistan, has become a priority of public policy.
