

Karshi branch of TIAME organized an interview for admitting applicants to the branch for correspondence courses for the 2021-2022 academic year on the recommendation of ministries, departments and large business associations.

It is important to suggest that there are several Resolutions of the State Commission for Admission to Educational Institutions of the Republic of Uzbekistan dated No. 2, July 20, 2021 and the Ministry of Higher and Secondary Specialized Education of the Republic of Uzbekistan, dated October 6, 2021. In order to ensure the implementation of the tasks set in letter No. 3634 in Karshi branch of TIAME for 2021-2022 academic year, the interview for admitting applicants in the form of distance learning with the recommendation of ministries, departments and large business of the association, the Commission began work on October 19, 2021. The chairman of the commission, director of the Branch Z. Mukimov said that at a meeting of the State Commission for admission to educational institutions of the Republic of Uzbekistan on July 4, 2019, to familiarize citizens with work experience of at least five years concurrently. Boltaev, head of the personnel department of Kashkadarya water supply LLC Sh. Bekmurodova, chief dispatcher G. Buryev. The branch was visited by the head of the personnel department of SE "Kasan" Sh. Burkhanov, the first deputy head of the Kashkadarya regional statistical department S. Safarov and the head of the personnel department of LLC "Kashkadarya agroservice MTP" F. Toshtemirova.

The candidates were introduced to the assessment criteria and interview procedures, and the interview process began after preparation. Applicants answered questions from members of the interview committee. The members of the commission assessed the applicants' answers to the questions posed. The executive secretary of the selection committee D. Kuvvatov announced the end of the interview and said that the results of the interview would be announced by the applicant in the near future.
