Courses should be taught during two weeks between November 1, 2019 - March 1, 2020.

The TIIAME now invites eligible international consultants to indicate their interest in providing the services. Activities expected by the Consultant will include but not be limited to the following:

- Preparation syllabuses of the courses and presentation materials
- Travel to Uzbekistan/TIIAME for 2 weeks to delivery training
- Provide advice to project team on the courses after end of training
